PENRYN COMMUNITY ACTION PLAN ADOPTED AND SET IN MOTION

On April 8, 2013, the Penn Township Board of Supervisors adopted the *Community Action Plan for the Village of Penryn, Pennsylvania*. After a one-year planning process, the Plan is complete but the work has only just begun. An action committee and an affiliated "walking club" are already making things happen in Penryn. These dedicated volunteers began regular meetings on the second Tuesday of each month to keep momentum going and continue with the improvements to Penn Township's historic village.

Currently, the community is creating designs for new, durable banners to hang from the utility poles in Penryn. They will proudly display themes such as "Heritage" and "Tradition" for locals and passers-by to see. Gateway signage, a historical marker, traffic calming, and walking routes are all projects being looked at right now. It's a full plate, but the people of Penryn have proven that they can get it done. Stay tuned!

SUMMERTIME ZONING AND CODES COMPLIANCE INFORMATION SWIMMING POOLS, HOT TUBS, & SPAS



Summer is almost here, and that means time to go swimming for many people. If you have a pool, hot tub, or spa at your home—or are looking to install one—please take note of the following important information:

\$403.26 of the PA Uniform Construction Code, as adopted by your elected state officials requires inspections of swimming pools capable of holding water deeper than 24", including the storable "inflatable ring" pools and all permanently installed hot tubs & spas.

Barriers or fences are required around all pools over 24" in height or depth. Above ground pools with outside walls of 48" or higher are considered their own barrier if they do not have a permanent means of access to the pool.



For storable pools, Penn Township requires a permit only for the first year if you are placing the pool in the same location in subsequent years.

The Township office has handouts for your review if you are considering a pool purchase.

THE PENN TOWNSHIP TRANSPORTATION CAPITAL IMPROVEMENT PLAN



In the previous edition of the Newsletter, we announced the commencement of this planning process as a way to assess the Township's transportation network, make critical decisions, and allocate resources to its long-term viability. Background data collection and future demand modeling has begun, based upon existing conditions and adopted planning documents.

An important aspect of the process is to conduct a series of public meetings to introduce the Plan, and solicit input from citizens and business owners. This input will be factored into the formulation of goals and objectives that support this tool. Even more importantly, public feedback will aid in the prioritization of safety enhancement and capacity building projects. Unfortunately, dates and locations for community meetings have not been set at this time.

PENN TOWNSHIP RECYCLING PROGRAM UPDATE

2012 municipal recycling data have been released by the Lancaster County Solid Waste Management Authority, and <u>Penn Township showed an overall</u> increase in recycling activity last year.

After essentially a full year of having a corrugated cardboard drop-off bin at the Township Campus, the results were noticeable: annual cardboard recycled in our municipality jumped from 237 to 359 tons! To put this in perspective, the amount of recycled cardboard as a percentage of total solid waste increased from 4.5% to 7.2%. Please remember that this bin accepts flattened, corrugated cardboard that is not stained by food or grease.



Thanks again to Goods Disposal Service, Inc. for providing the cardboard bin free of charge to Penn Township residents.

Overall, 18.9% of Penn Township's total solid waste stream was recycled. Residential and commercial; curbside and drop-off; bottles, cans, and cardboard—all of this is part of the equation. Although our municipality's recycling rate is less than half of the Lancaster County average, this rate was improved from 2011 as well. Keep up the good work!

TRASH HAULER SURVEY RESULTS COMPILED

In the Spring 2013 edition of the Township Newsletter, we asked you whether Penn Township should contract with a single



hauler on behalf of all residents. Within weeks of publication, 69 people responded and shared their thoughts on the issue.

While 23 respondents were in favor of some sort of a Township-contracted program, the other two-thirds felt that the current system that allows each household to choose their trash hauler works just fine. These results were shared with the Board of Supervisors at a public meeting, and no further action on moving to a single-hauler system was taken.

Thank you to all who responded and gave feedback for us to consider.
