Approval for wastewater service may be regulated or restricted by the Authority or other state and federal agencies. Laws, regulations, restrictions, and court decisions beyond the control of the Authority may prohibit or delay the Applicant from receiving final approval to use all or a portion of the approved water and/or wastewater capacity.
