
- Lititz Road scratch and overlay

Other


- Received \$13,757 in dividends from co-op health, liability, and worker's compensation self-insurance plans

Penn Township Plans Yard Waste Facility at 97 North Penryn Road



The long awaited yard waste facility is open! A fob is required to enter the facility. Complete the Fob & Re-Activation Application (https://penntwplanco.org/wp-content/uploads/2024/12/Fob-Re-Activation-Application.pdf) and complete and submit it to the Township with \$20.00 (cash or check made payable to Penn Township). Please allow 48 hours for key fob application processing.

Yard Waste Rules & Regulations can be found on page 2 of the application and in the 2025 Fee Schedule: Section 27. Yard Waste Site Fees and Rules.

(a) All key fobs are active for one year; fees are not prorated; key fobs are for residential use only and for property owners only

- (b) \$20.00 per key fob per property or to replace a damaged or lost fob
- (c) \$20.00 to renew fob annually
- (d) Cash or check made payable to Penn Township
- (e) Penn Township residential property owners only
- (f) Place items in designated areas
- (g) No smoking
- (h) The use of chain saws and similar equipment is prohibited
- (i) All children under age 16 must remain in the vehicle
- (j) Skateboarding, rollerblading, bicycling or any similar activity is prohibited within the facility
- (k) Leaves, garden waste, shrubbery, and tree trimmings only
- (l) Leaves may be loose or bagged in paper bags (bags can be purchased at any hardware store)
- (m) Tree trimmings, up to 8 inches in diameter, maximum 8 feet in length
- (n) Christmas trees must be free of all ornaments and all other decorations
- (o) No grass clippings
- (p) Nothing else allowed

(q) Any use of the facility in violation of the rules, including but not limited to the following, will result in prosecution and loss of access:

- a. Use of your key fob by someone else not living on your property
- b. Dropping any items not accepted by the facility
- c. Damage to gates, signs, walls, fences, landscaping or any other property damage

(r) Violations of these rules are violations of Township Code of Ordinances Chapter 20, Solid Waste

2025 Public Works Projects

- North Penryn Road from Newport Road to the Elizabeth Township line is scheduled for paving, scratch and overlay
- Fairland Road from Fruitville Pike to Sego Sago Road is scheduled for road widening
- South Penryn Road at Indian Village Road permitting and the line pipes
- Cool Spring Road at the Doe Run Road intersection, replacement of pipes and inlets
- East Mount Hope Road near the Mountain Road intersection, pipe and inlet work



Housing

Everyone deserves a safe place to live but what happens when your income can't keep up with the pace of housing? More and more people in Lancaster County are homeless or housing-cost burdened.

The need for affordable housing in the county is described as "beyond urgent," a "fire alarm," and a "crisis."



Young people, even those with good paying jobs, are unable to purchase their first home because the cost of the down payment and monthly payments are too staggering in addition to other debts they may or may not have. Seniors, especially those on a fixed income, and looking to downsize are unable to find housing that meets their physical and financial needs. Working families, especially those in service jobs, are also unable to purchase a home because of the staggering costs.

Recently, HDC MidAtlantic, held an Afforable Housing Deliverative Workshop. Many voiced concern that more people will find themselves homeless if the need for affordable housing isn't addressed soon. Participants of a housing workshop felt that there is stigma and stereotypes attached to those in need of affordable housing and called for more education of the public to correct misconceptions. Many thought opposition to affordable housing is often grounded in concerns about public safety. Research does not support this concern and good planning develops housing that provides a safe place for all to live and thrive.

What does homelessness look like in Lancaster County, particularly rural Lancaster County?

Many in rural Lancaster County, including in Penn Township, who are considered homeless, may not be able afford to rent or purchase a home possibly because they lost their job or for medical reasons beyond their control, or because it is not safe to be with others in their household. As a result, these people, live on a neighbor or friends' couch, in a car, or huddled in a tent along a street, park or creek.

What is 'housing-cost burdened'?

Housing-cost burdened is when a household pays more than 30% of their income towards housing including the cost of rent or mortgage with interest, renters/homeowners insurance, fees such as HOA fees, and utilities such as trash & recycling, gas, electric, water & sewer.

What are the barriers to making housing more affordable?

Barriers to making housing more affordable include:

- Zoning and Land Use Regulations
- Construction Costs & Housing Regulations
- NIMBYism (Not In My Backyard)

Municipalities may be able to change some zoning, land use or housing regulations however many they cannot. These often require State or Federal government legislation action to change. Construction costs are largely regulated by the open market. NIMBYism - Objections by community members to new housing development, especially those that are close proximity to them, because of fear or prejudice. Housing is a basic human right and the cornerstone of growth and stability for individuals and families. Why does NIMBYIism occur and how do we overcome the NIMBY (Not In My Back Yard) effect?

Many of us fear:

- 1. Change or the Unknown Resistance especially when surroundings change
- 2. Perceived Negative Impacts Believe new development will negatively impact their quality of life
- 3. Property Value Concerns Fear that Affordable Housing will lower property values
- 4. Lack of Information Misinformation and misunderstandings can fuel NIMBYism

VS.

Feelings

- 1. Concern about increased traffic and \succ Tend to have fewer cars and generate parking.
- 2. Concern about large families overcrowding and burdening schools.
- 3. Concern that residents of affordable housing don't work.
- 4. Concern that the property doesn't contribute to the local tax base.
- 5. Concern that property values will decrease.
- 6. Concern about low quality construction and being poorly maintained.
- 7. Affordable housing increases crime.

Facts

- fewer vehicle trips. > Tend to have fewer occupants and school age children.
- \succ Residents are wage earners.
- > Pays real estate taxes (city, county, school)
- > Research shows no reduction on home values
- > Public and private funding help to make housing more affordable, not because it's lower quality construction.
- > There is no evidence that shows affordable housing brings crime to neighborhoods
