- Subdivision/Land Development (S/LD) Plans must be received and accepted by the Lancaster County Planning Department (LCPD) at least 30 days prior to the desired Lancaster County Planning Commission (LCPC) meeting date.
- Community Plan, Map, and Ordinance (CPO) submissions must be received and accepted by LCPD at least 45 days prior to the desired LCPC meeting date. These submissions include proposed adoption, amendment, or repeal of comprehensive plans, ordinance text, zoning maps, and official maps.
