Call to Order and Pledge of Allegiance: Ben Bruckhart opened the meeting at 7 p.m. with the Pledge of Allegiance.

 - d. A motion by Eisenhauer seconded by Landis was approved 5 to 0 to adopt Resolution 2026-04 Appointment of Township Consultants, as corrected.
 - e. A motion by Landis seconded by Walsh was approved 5 to 0 to adopt Resolution 2026-05 Appointment of Public Accountant and Compensation to be Paid.
 - f. A motion Walsh seconded by Stevens was approved to adopt Resolution 2026-06 Appointment and Compensation of Township Manager.
 - g. A motion by Landis seconded by Walsh was approved to adopt Resolution 2026-07 Fee Schedule Including Engineer and Solicitor Fee Rates.
7. A motion by Eisenhauer seconded by Stevens was approved 5 to 0 to appoint Randall Wenger as the primary municipal voting delegate and Joel Mutschler as the alternate municipal voting delegate to serve on the Lancaster County Tax Collection Bureau's Management Committee for 2026.
8. A motion by Landis seconded by Eisenhauer was approved 5 to 0 to adopt the IRS 2026 Standard Mileage Reimbursement Rate of 72.5 cents per business mile driven (as corrected).
9. Resolution 2026-08, Add 1691 Junction Road Farm to Agricultural Security Area was motioned by Landis, seconded by Stevens and approved 5-0.
10. Resolution 2026-09, EMS Cost Sharing Agreement was motioned by Eisenhauer, seconded by Stevens and approved 5-0.
11. Approval of the Election Polling Place Agreement was motioned by Eisenhauer seconded by Walsh and approved 5-0.
12. Appoint Reece Pyfer as a Penn Township representative to the Manheim Community Library was motioned by Walsh seconded by Eisenhauer and approved 5-0.

Communications were noted from the Portnoff Collections Report.

Reports were reviewed from Building, Zoning, and Property Maintenance (No report due to A&M Compost Fire) and Public Works noted the wrong size stop sign was installed at the Junction Road Railroad Crossing, which has since been fixed. And the PA One calls have increased a lot this year, due to changes in when you should call.
